We are simply providing a calming space to use the device for single use instead of purchasing a device for at home use. The device can also scan the body for any frequency imbalances and make program suggestions to bring those areas back to harmony. The device can also make generic program recommendations for any identified issues in the body. We are not direct representatives of the Healy World Company but we are affiliates of their many frequency therapy devices. We love their products, use their products and now have the ability to offer services to our community using their products.

At Good Vibes Wellness Center we offer free consultations for those wanting more information on how frequency therapy could support their health and wellness.

The device we use to deliver our sessions uses "Individualized Microcurrent Frequencies" ("IMF"), which is a proprietary technology of Healy World. I will rely on the healy informed team to exercise judgment during the course of the session which they feel at that time is in my best interests based on the facts then known. With this knowledge, I voluntarily consent to scans and appropriate Healy frequency programs administered by the Good Vibes Wellness Center team who are also Healy World Independant Members. I understand this consent form is to cover the entire course of my session for my present expressed condition. I understand that I am free to withdraw my consent and to discontinue participation in these sessions at any time. If I experience any pain or discomfort during this session I will immediately inform the team.

I understand that these services offered at the Good Vibes Wellness Center are not covered under provincial health care. Frequency Therapy Sessions may be tax deductible or covered by

extended health care benefit plans. Please check with your insurance provider for coverage. Healy Frequency therapy is a joint responsibility between myself (the patient) and the Good Vibes Wellness Center Team. I _____ have read this notice and understand its contents.

Sanitation Policy

Team members at the Good Vibes Wellness Center will make every effort to maintain a clean, safe environment. This includes regularly sanitizing the space, session room, chairs, device, bands and cords. If electro pads are required they will be new and unused. If returning for additional sessions the same pads will be used until no longer adhesive. Pads will be stored in a sealed bag in the client file.

Cancellation and Refund Policy

In the case of emergencies or if you wake up sick for your appointment, we require at least 4 hours' notice. Appointments that aren't canceled within 4 hours will be considered a "no show" and will be charged as a full Session. If you cancel between 4 and 24 hours before your appointment, charges will be based on the discretion of the team or applied to your next session. If you cancel 24 hours in advance of your appointment, you will not be charged any cancellation fees. If you cancel between 4 and 24 hours before your appointment, you may be charged up to 50% of the cost for the scheduled appointment. This fee will be charged at the discretion of the Good Vibes Team Member, depending on whether or not we can refill the appointment.

If you're feeling unwell and believe you may have a contagious illness, we ask that you stay home. If you're experiencing fever, vomiting, diarrhea, or coughing, please cancel your appointment with at least 4 hours' notice. If you aren't sure if you should come to your appointment, you can text, email, or call us to ask.

Good Vibes Wellness Center does not offer refunds on completed services unless the session is not able to be finished due to complications. Client understands this is a holistic Center and Healy frequency therapy often works best in conjunction with other forms of therapy and need not be considered exclusively beneficial. Healy Frequency therapy is cumulative in which regular sessions can invite significant improvement.
